

LEVEL 4 CONSTRUCTION SITE SUPERVISOR APPRENTICESHIP

The occupation covered by this standard is Construction Site Supervisor, with typical job titles including Assistant Site Manager, Assistant Supervisor, or Construction Site Supervisor. In SME construction companies, these roles may extend to Site Manager or Site Supervisor. These professionals supervise specialist contractors and workers on construction projects, primarily working on construction sites with occasional office time.

The main duties and tasks of a Construction Site Supervisor include the supervision of specialist contractors, ensuring health and safety standards on construction projects, recording, controlling, and reporting project progress, minimizing the environmental impact of construction projects, controlling the quality of work, and assisting commercial staff in monitoring project costs.

Programme Delivery

Throughout the apprenticeship, the apprentice will be engaged in various activities to build their portfolio and enhance their skills in the workplace. Your apprentice will be required to attend college practical workshops building on their skills learnt at College and at work, knowledge lessons and complete a portfolio of evidence. They will also undertake some self-directed study to further their understanding. Additionally, the apprentice will have regular progress reviews with their employer and Lecturer Assessor to ensure they are on track. Apprentices will complete a mandatory Level 4 Construction Site Supervisor Qualification.

Duration

The apprenticeship will typically takes 36 to complete. (This does not include EPA period)

Funding

Levy paying employers can fund apprentices on this programme from their apprenticeship account and non-levy paying SMEs through the co-funded option. There may be a small fee for some SME's if your apprentice is over the age of 21. You can get support for funding through the Construction Industry Training Board CITB.





Outcome

At the end of the apprenticeship, your apprentice will achieve their Apprenticeship and be able to apply for a Supervisory CSCS card. The End Point Assessment (EPA) has 3 assessment methods a project, a professional discussion and an online knowledge test.

This Apprenticeship will include the knowledge, skills and behaviours typically required to achieve Technician status or the equivalent with the industry's recognised professional bodies. The final assessment process for this Apprenticeship will typically be representative of the review process required for professional registration.



Entry Requirements

Individual employers will determine their own entry requirements, but the typical entry requirements for this Apprenticeship will be five GCSEs or equivalent, including Maths, English and a Science; or a Level 2 Apprenticeship.

To ensure apprentices meet the maths and English Level 2 requirements, we provide Functional Skills lessons, offered alongside their apprenticeship, to those who have not achieved a level 2 or equivalent. At application stage we will assess current literacy and numeracy levels to determine suitability and any support needs.



Knowledge, Skills & Behaviours

Knowledge, skills, and assessment for this role include:

Understanding risk assessments and the significance of behaviour in safety-critical environments is crucial. Recognising sustainability issues in projects, across economic, social, and environmental aspects, is essential for maintaining ecological responsibility. A solid grasp of different construction methods and materials is necessary, as is familiarity with management principles and the project management lifecycle. Effective planning and organising of work are vital, including the ability to analyse various planning techniques. Monitoring quality involves defining the required standards for finished construction projects while understanding cost control is key to managing project expenses effectively.
